RENEWAL/ SANCTION OF AFFILIATION ORDER

State Board of Technical Education & Training, Andhra Pradesh was established as per sub-sections (1) and (2) of Section 6 read with sub-section (1) of Section 99 of the Andhra Pradesh Education Act. 1982 (Act No.1 of 1982), vide G.O. No.140, dated 24-04-1984 of Labour Employment, Nutrition and Technical Education Department, Govt of Andhra Pradesh to offer Diploma courses in Engineering and Technology and D. Pharmacy in liaison with All India Council for Technical Education, New Delhi, Council of Architecture, New Delhi and Pharmacy Council of India, New Delhi.

The State Board of Technical Education and Training, Andhra Pradesh Mangalagiri, the affiliating body, is pleased to issue the Renewal/ Sanctioning of Temporary Affiliation to the following Existing/New/Aided/Private Polytechnics including Private Engineering Colleges conducting Diploma in Pharmacy (D. Pharmacy) Course under the control of SBTET in the State of Andhra Pradesh for the Academic Year 2025-26.

1. All the colleges/institutes including Government/Aided/Private Polytechnics offering Diploma in Pharmacy (D. Pharmacy) Course in the state of Andhra Pradesh should be affiliated to State Board of Technical Education & Training, A.P. The Academic activities, conduct of Examinations and Award of Diploma certificates to the students of all the affiliated colleges/institutes shall be guided, monitored and regulated by the State Board of Technical Education & Training, Andhra Pradesh (Affiliating Body), as per the instructions and directions of the Department of Technical Education, Government of Andhra Pradesh from time to time.

2. All Aided and Private colleges/institutes offering Diploma in Pharmacy (D. Pharmacy) Course in the State of Andhra Pradesh should Pay the Affiliation Fee to SBTET, A.P., as prescribed by the State Board of Technical Education & Training, A.P to get Affiliation for each Academica Year.
3. All the Affiliated colleges/institutes with SBTET, A.P must follow the curriculum prescribed by Pharmacy Council of India, New Delhi and Published by SBTET, A.P., from time to time ensuring that the student receives Quality Education that is recognized and widely accepted by all other State Technical Boards in India.
4. SBTET, A.P Conducts academic inspections at regular intervals to monitor the ongoing activities with the standards prescribed by the Department of Technical Education, Government of Andhra Pradesh and Pharmacy Council of India, New Delhi.
5. SBTET, A.P Conducts Board Diploma Examinations to the students studying in the colleges/institutes for the academic year 2025-26.
6. SBTET, A.P Conducts Board Diploma Examinations to the students having backlog subjects as per the rules for the academic year 2025-26.
7. SBTET, A.P issues Marks Memos and Original Diploma Certificates to the passed-out students in the academic year 2025-26.
8. SBTET, A.P deputes the Staff working in the colleges/institutes for various confidential works assigned by DTE/ SBTET, A.P, from time to time.

The inspection team is recommended for renewal of affiliation to conduct the Diploma in Pharmacy (D. Pharmacy) course with the intake for the Academic Year 2025-26 in:

Important Notes:

1. The college will be considered and forwarded for admissions with the recommended intake for the academic year 2025-26 to the Department of Technical Education, subject to the intake approved by the Pharmacy Council of India (PCI) and timely submission of the PCI Decision Letter 2025-26 to the Secretary, SBTET, A.P.

2. It is mandatory for all colleges to adhere to the Circulars, rules and regulations laid down by the Pharmacy Council of India (PCI), New Delhi as published on its official website from time to time and also as detailed in the Decision Letter for the academic year 2025-26.
3. The recommended intake shall be **mandatorily reduced** in accordance with the intake approved in the Decision Letter issued by the Pharmacy Council of India, New Delhi, for the academic year 2025-26.
4. The recommended intake may be increased as per the Decision Letter approved by the Pharmacy Council of India, New Delhi, provided the concerned college/institute has submitted a **No Objection Certificate (NOC)** from the Director, Department of Technical Education (DTE, A.P.) to the Secretary, State Board of Technical Education and Training (SBTET, A.P.) for the academic year 2025-26 in time.
5. In case of any discrepancies found in the content in this affiliation order, the content/information recommended by the inspection teams available in the inspection records submitted to SBTET, A.P shall be final and binding.

The Principal/Correspondent is informed that the deficiencies, if any, noted in the inspection report submitted by the inspection team appointed by SBTET-A.P for the academic year 2025-26, shall be complied by the college. The college will be forwarded for admissions for the academic year 2025-26 to the Department of Technical Education only after submitting the compliance letter to the Secretary, SBTET, A.P in time.
